(IOCL) on the basis of this affidavit and information submitted by me in the Know Your Customer (KYC) form, Proof of Address and Proof of identity, shall later be subjected to de-duplication check for existence of any other domestic subsidized LPG connection with any Govt. Oil company, in my name or in the name of any other member of my 'household' as at para '3' above.
