FOR THE TRANSPORTATION WORK OF GYPSUM POWDER IN THE YEAR 2019-20.

1. All bidders are cautioned that bid containing any deviation from the contractual terms and conditions shall be rejected.
2. Conditional bids shall be rejected.
3. Award shall be made to the bidder whose offer is responsive, lowest and who meets the appropriate standards of capability and financial resources.
4. Alternative bid are not acceptable.
5. Quantities taken in bid documents may vary.
6. The bids security of unsuccessful bidders shall be refunded as early as possible, after ascertaining successful bidder. The bids security of successful bidders shall be adjusted against performance security and there is no interest shall be payable on such deposit amount.
7. An agreement shall be executed by the successful bidder within 07 days of obtaining work order.
8. The bid security shall be forfeited in the following circumstances :
 - If the bidder refuses to accept the bid or proposes any changes in conditions of bid
 - If the bidder does not execute the contract within the stipulated time as mentioned in bid document.

12. It is essential to mention rates of FOR destination of transportation for all the districts of Rajasthan at the level of various KVSS/GSS for particular district inclusive unloading charges and any other charges/tax etc. thereon.
13. The road tax, insurance, toll tax etc. shall be borne by the transporter firm.
14. The transporter firm shall ensure the **delivery of gypsum bags within 10 days.**
15. If the transporter firm does not supply the gypsum powder within stipulated time and breaches the agreement, in this situation the Federation reserves all the rights to appoint other transportation firm for such supply on the risk and cost of defaulter firm and also performance security amount shall be forfeited. There is no legal right of the transportation firm against such recovery and forfeited amount.
16. The transporter shall have to supply to the societies from the grinding units as mentioned in Demand Instructions of the Federation.
17. The D.I wise daily dispatch report shall be provided by the transporter firm to the Federation and concerned Dealer through e-mail. The transporter firm shall have to submit its transportation bill along with G.R.and receipt duly seal & signed by the Manager of KVSS/GSS. If, any loss occurs due to non submission of daily supply report, the same shall be recoverable from the firm.
18. (A.) The 95% amount of the transportation bill along with G.R. and necessary details submitted for payment shall be payable within 15 days, remaining 5% amount shall be kept as security deposit and payable after satisfactory report. There is no interest payable on such security deposit. If the payment of the bill made through DD, the bank charges shall be borne by the firm.
