Failure to provide information, which is essential to evaluate the bidder’s qualifications or to provide timely clarification or substantiation of the information, supplied my result in disqualification of the bidder.

The bidders should provide accurate information otherwise bid will be rejected.

The bidders shall be required to update the financial information used for Pre Qualification Bid at the time of submitting their bids, to confirm their continued compliance with the qualification criteria and verification of the information provided. A bid will be rejected if the bidder’s qualification thresholds are no longer.

Financial bid of those firms who have qualified under this procedure shall be opened.
